# **Booking Conditions**

# Please read carefully the terms in the Conditions of Contract and waiver of liability as outlined below.

# Your contract is with White Magic Adventure Travel Pvt Ltd.

Below are the details of the terms and conditions of the booking agreement. Please read them carefully. When you make a booking and we accept it, a legally binding contract is made. When you sign a booking form or fill one in online, you (and any other person on whose behalf you book) agree to accept all of these conditions; you acknowledge that you have read the relevant trip information and also the general information. You also warrant that the information given by you on the booking form is complete and true. This contract is made on the terms of these booking conditions.

### I. How to Book

To reserve your place on any of the trips organised by White Magic Adventure Travel Pvt. Ltd., you should fill and sign the booking form and send it to our office by email (a scanned copy), fax, post or courier.

#### 2. Payment

The prices quoted are for payment by cash, draft, wire transfer, cheque or money order, payable in New Delhi. The tour price is payable to White Magic Adventure Travel Pvt. Ltd, 45 days prior to departure. Failure to pay by that date entitles White Magic Adventure Travel Pvt. Ltd. to cancel your booking without notice and without refund of the deposit. Prices are quoted in Indian National Rupees (INR) / US dollars (USD). For some special trips, the booking date may be upto 2 months before departure.

#### 3. Package Prices

The cost quoted for any of the trips is a package cost and the trip quote lists out all the cost inclusions & exclusions. Package prices are based on ground costs, airfares and exchange rates. White Magic Adventure Travel Pvt. Ltd. tries its utmost not to increase tour prices (in full or part), however sometimes increases are outside its control. We reserve the right to amend tour prices (or any part) without notice at any time before and including the departure date. Amendments may be necessitated for many reasons including, but not limited to, exchange rate fluctuations, increased fuel costs, airfares, airport charges etc. Any increase in tour prices must be paid prior to the departure date.

#### 4. Health and Fitness Requirements

Participants must be in good health and reasonable physical condition. It is vital that participants with medical problems make them known to us well before departure. Our trips generally take place in remote areas where there is little or no access to normal medical services or hospital facilities. If required, evacuation can be prolonged, difficult and expensive. Medical and evacuation expenses will be the responsibility of the participant.

# 5. Tour Leader Authority

Signing our booking form signifies your agreement to abide by the authority of the leader, who represents White Magic Adventure Travel Pvt Ltd. The decision of the leader as to the conduct, itinerary and objectives of the tour is final. If, in the opinion of the leader, your behaviour or physical condition is detrimental to the safety, we lfare and well-being of the group as a whole, or if the leader considers your general wellbeing will be put at risk by continuing with the trip, you may be asked to discontinue the tour. In this case you would not be entitled to any refund for unused services.

# 6. Cancellations

If it becomes necessary to cancel your tour, you must notify White Magic Adventure Travel Pvt. Ltd. immediately in writing. Once we receive your notice, cancellation will take effect. Please note that the following charges will apply on cancellation:

- if cancellation takes place more than 45 days prior to departure, your full deposit will be returned except a processing charge equivalent of 5% of trip cost, excluding tax component; (60 days for Outbound trips)
- if cancellation takes place between 45 and 30 days prior to departure, 50% of the tour price will be forfeited (between 60 and 30 days for Outbound trips); and
- if cancellation takes place less than 30 days prior to departure, 100% of the tour price will be forfeited.

Some trips attract a minimum processing charge – please check. The tour price is quoted as a package. No partial refunds or credit will be given for services not used. We recommend that you obtain cancellation travel insurance upon booking. If you can replace your spot by getting someone else to take that seat cancellation charges would be waived completely. You would only be charged the processing fee of 5%.

#### 7. Delay, Cancellation or Change of Itinerary

White Magic Adventure Travel Pvt. Ltd. reserves the right to cancel any expedition prior to departure (including, but not limited to, by reason of too few people booking on any tour) in which case participants will be given a refund in full. However, you will not be entitled to make any further daim for any injury, loss, expenses or damage (either direct or consequential) or for any loss of time or inconvenience which may result from such cancellation (including but not limited to visa, passport and vaccination charges, or departure, gear purchases, airport and airline taxes). It is possible that a route change, postponement or delay (either in relation to departure or to the duration of the expedition) may become necessary due to inclement weather, snow and ice conditions, political restrictions or any other cause. In the event of a change, postponement or delay, participants have no right to refund of the tour price (in whole or in part) or other compensation for any injury, loss or damage.

### 8. Force Majeure

White Magic Adventure Travel Pvt. Ltd will not be liable to pay the participants the compensation/refund if it has to cancel or change the travel arrangements in any way because of war, riot, industrial dispute, terrorist activity, natural or nuclear disaster, fire, adverse weather conditions or other unforeseen circumstances that may amount to *force majeure*.

#### 9. Travel & Cancellation Insurance

It is important that you must be covered by adequate insurance for the complete duration of your trip. Your insurance must include cover for; medical expenses, injury, death, cost of repatriation and evacuation via whatever means necessary induding by helicopter/air ambulance. If, in the event of an emergency medical rescue or evacuation from a trip, either by foot, helicopter or otherwise the responsibility for the payment of such costs will lie directly with you. Any subsequent costs incurred for expenses such as hotels, food, transport etc shall be borne by you. We do not check insurance policies. We reserve the right to cancel your booking at any time before departure if we are not satisfied that adequate insurance is in place for you. All baggage and belongings are entirely at your own risk at all times and we will not take responsibility of loss, damage or accident to any luggage or property.

I waive any and all claims I may now and in the future have against, and release from all liability and agree not to sue White Magic Adventure Travel Pvt. Ltd. and its officers, employees, guides, agents or representatives (collectively its staff) or the licensor for any personal injury, death, property damage, or loss sustained by me as a result of my participation in an adventure trip with them, due to any cause whatsoever, including without any limitation, negligence on the part of White Magic Adventure Travel Pvt. Ltd., its staff and licensor. I am aware that your adventure trip, in addition to the usual dangers and risks inherent, has certain additional dangers and risks, some of which may include: physical exertion for which I may not be prepared; weather extremes subject to sudden and unexpected change; remoteness from normal medical services; evacuation difficulties if I am disabled. I accept all the inherent risks of the proposed adventure trip and the possibility of personal injury, death or property damage or loss resulting therefrom. I acknowledge that the enjoyment and excitement of adventure travel is derived in part from the inherent risks incurred by travel and the accivity beyond the accepted safety of life at home or work, and that these inherent risks contribute to such enjoyment and excitement, being a reason for my participation. I agree that if I suffer injury or illness White Magic Adventure Travel Pvt. Ltd, can, at my cost, arrange medical treatment and emergency evacuation service, as they deem essential for my safety. In entering into this Agreement, I am not relying on any oral, written nor visual representations or statements by White Magic Adventure Travel Pvt. Ltd. or its staff or any other inducement or coercion to go on an adventure trip, hence, only of my own free will.
